## An MP's Case Requested for 10 million Kyats Finalized

July 16, 2018

The case of MP U Aung Kyaw Myaing asked for 10 million kyats to provide electric access in the villages has already been inspected. MP U Aung Kyaw Myaing, Constituency-2, EainMe, Ayarwaddy Region, has to make a promise and to give his signature before the Hluttaw Speaker and Hluttaw Representative Vetting Committee, according to Hluttaw Deputy speaker U San Min Aung.

According to the Hluttaw Office, although MP U Aung Kyaw Myaing was involved in asking for the money, he did not spend it for his benefits. Although there were no concrete documents that he was involved in corruption, he had to make a promise and signed that he as a MP was involved in finance issues, which were spent not in line with the ethics, mismanagement, and

performed for the facts that could make the public misunderstand.

MP U Aung Kyaw Myaing asked for 100 Lakhs from the rural [village] electricity access committee to spend for the electricity access in Nyaungkon-Chaungpyar village (although the budget was initially allocated for Takaw village, but the title was switched to Nyaungkon-Chaungpyar village), in EainMe Township. But freelance reporter Ko Thura Soe from EainMe Town got the information, and MP U Aung Kyaw Myaing requested the reporter not to write about that. Yet, the reporter did not accept. The MP then had to return the budget to the village on March 27. Reporter Ko Thura Soe then reported that to the anti-corruption commission, according to the Hluttaw Office.

## 69 Candidates for MPs Compete in the 2018 By-election

July 13, 2018

U Myint Naing, a member of Union Election Commission (UEC), said on July 12 that a total of 69 candidates for MPs from 24 parties, including 7 independent candidates have enlisted to compete for the 2018 by-election.

The Union Election Commission announced that MP candidate names can be enlisted for vacant parliamentary seats from July 2 to

July 11.

The ruling National League for Democracy (NLD) has announced that it will compete for all the vacant seats and has put forward 13 names from the party.

The opposition party Union Solidarity and Development Party (USDP) has also stated that it would run for the by-election although not for some seats in certain States. It has proposed names for the vacant seats for constituency (10).

The Union Election Commission announced that the 2018 by-election will be held on November 3 in 13 constituencies with vacant seats.

The Union Election Commission has also announced that voter name list will be posted from July 9 to September 22 in Election Commission Office in the 13 constituencies where the by- election will be held.

## 75% of Mrauk-U Riot Study Report Completed

July 8, 2018

Mrauk-U Riot Inquiry Group formed by the Rakhine State Hluttaw has completed 75% of its inquiry report, according to Group's Secretary and Mrauk-U Hluttaw MP U Tun Thar Sein.

"We have met with the family members before. Now, we have already conducted field work twice. But we have not met with the authorities yet," said MP U Tun Thar Sein.

U Tun Thar Sein, however, continued that the decision for the Inquiry Group to meet with the authorities would be made after July 10. He's yet known whether the report would be submitted at the 8th Regular Meeting of the Rakhine State Hluttaw.

The Inquiry Group was formed with 9 members, including 7 MPs and 2 members of legislative advisory group, at an emergency meeting on January 29.

Some public criticize for the fact that the report is yet released, although it has already been over 5 months after the group is assigned for the inquiry.

"We have to analyze (information) based on different situations. There

are the cases that we cannot unveil to the media, like what will happen to the penalties for those arrested people, when we release our report,

We also have to speculate," said MP U Tun Thar Sein.

### Government Urged to Take Action on Lousy Vendors at Yangon Public Hospital

A video of wandering vendors engaged in a fight in the Yangon Public Hospital compound was shared widely on social media [Facebook] pages. Thus, since the itinerant vendors are [temporarily] living, selling at the hospital and breaking the rules, the Yangon Hluttaw Speaker urged the Yangon Region government to take action, according to Yangon Hluttaw Social and Management Committee.

The vendors were gambling under the building of heart treatment (A), of the Yangon Public Hospital, when the fight broke out on July 5.

The vendors at the hospital are expanding their shops, selling (foods) at their shops without following rules, living at the hospital, dropping the trash, making noise, using electricity, water and toilets of the hospital, setting up drinking group and engaging in fighting, according to those who are in-charge at the hospital.

The above-mentioned has caused lots of disruptions to people working at the hospital, according to Dr. Thein Myint, head of Gastric Intestinal Treatment Department.

In order to find solutions regarding the lousy vendors' issue on July 5, the Yangon Region Hluttaw Social and Management Committee had meeting with the local MPs, heads of the hospital and doctors, township general administrator, Township police Chief, heads of township municipal.

### Kachin Hluttaw Speaker Reminds Social Affair Minister to Answer with Accurate Information

Kachin State Hluttaw Speaker U Tun Tin reminded Dr. Thin Lwin, the Social Affair Minister on May 25, at the 12<sup>th</sup> Regular Kachin State Hluttaw meeting that the Minister should respond with precise information when the Hluttaw representatives asked the questions.

MP U Chang Dang Hken (Naung Mon Constituency -1) raised three questions at the second day of the 12<sup>th</sup> Regular Hluttaw Meeting regarding job opportunities for recent university graduates. Of 3 questions, when the Social Affair Minister replied to one question, the minister did not give a full answer. Instead, he said he would ask the respective departments and then give the answer.

Thus, the Hluttaw Speaker warned the Social Affair Minister, "The questions that MP asked as for the vacant posts for individual departments. Can the [local] ethnic people appoint that? The [social affair] minister is responsible for the government group too. Thus, for future questions, the ministry got time. And [he/she] should come to the Hluttaw only after [he/she] has gathered the precise data."
