
Over 50 Questions Asked at the Meeting between Sagaing Locals and Parliamentarians

Tuesday, 12th July 2016

A meeting between Sagaing locals and parliamentarians was held at Sagaing City Hall at 9 am on 12th July and over 50 questions including land issues were responded.

The MPs said that they attended the meeting because they could learn people's wishes, needs and requests and could submit them to the parliament and similarly the public was able to learn MPs' activities through the meeting.

"We plan in a way that people are allowed to ask what they want to know and respective MPs will answer. People have to ask public issues, not private ones. Each person can take 3 minutes for questions", said U Khin Maung Latt who is a Pyithu Hluttaw MP.



At the meeting, the locals asked over 50 questions including land issues, local development activities and administration of Sagaing jade market.

Yangon Region Hluttaw's Committee of Judiciary, Rule of Law, Complaints and Plea Letters to Make Field Observations in Courts and Police Stations in Yangon Region

It was learned from U Kyaw Kyaw Htun, who is an MP and a member of the Judiciary, Rule of Law, Complaints and Plea Letters Committee that the committee would make field observations in

courts and police stations in Yangon.

He said that the committee would observe clients' needs, challenges faced by judiciary personnel including judges, difficulties faced by detainees in police stations and police forces and their families' needs, which would be presented to the coming parliament session.

"We will not interfere with the judiciary pillar, but just negotiate in a check-and-balance manner between the pillars," he went on saying.

The committee had already received committee-meeting decisions to carry out observations in courts and police stations in the region tentatively during the last week of July and soon a meeting will be held to determine exact dates.

Local authority and parliamentarians will scrutinize and submit development schemes to the region cabinet, yet a deadline has not been set up.

According to the decision reached by the postelection tribunal appealing case (1/2016) dated 12th July 2016 under Union Election Commission, U Aung Kyaw Nyunt was revoked as the representative in Lawksawk Constituency (1), Shan State and was replaced with U Khaing Nyi Nyi Kyaw in accordance with State/Region Hluttaw Electoral Law, Article 75(a).

The Committee of Municipal, Rural Development and Enterprise Development, the Committee of Agriculture, Livestock, Fisheries and Irrigation, and the Committee of Citizen Rights and Special Investigation of the Rakhine State Hluttaw made a field investigation to Kyaukpyu, Ann and Thandwe townships. After investigating farmland destruction in Ann and Thandwe due to the gas pipeline, findings and a separate recommendation report are to be submitted to the state hluttaw. The gas pipeline runs from Kyaukpyu across Myanmar middle region and Shan State to China's Yunnan Province. There were objections in Kyaukpyu and Ann from where the gas pipeline runs because of farmland destruction of the locals and there were frequent protests calling for settling problems arising from the gas pipeline.
